Minutes of General Membership/Executive Committee Meeting April 10, 2019 – College of San Mateo

The meeting was called to order at 2:27pm.

- 1) Welcome and Introductions
- 2) Statements from AFT members (non EC members) on Non-Agenda items
 - a) Arielle Smith reported on discussion of dual enrollment at Academic Senate.
- 3) Negotiations Discussion of Counselor Load
 - a) EC discussed counselor load discrepancies with respect to contract/current negotiation priorities.
- 4) Negotiations-Discussion on Music/Art Faculty Load Credit (FLC)
 - a) Discussion on FLC challenges for Art Department including
 - i) Skyline Art department requests change to contract with addition of specific line for Art labs in Appendix F giving Art labs parity with science labs.
 - ii) Art professors' load includes doing the work of lab technicians.
 - b) District music faculty reported challenges resulting from TMC (AAT) and problems including:
 - i) Recently decreased pay for adjuncts due to lab rate.
 - ii) Despite nomenclature, music labs are not "pure" labs but instructor directed courses with lecture interlaid and homework assigned; students in these classes must demo specific skills to transfer, requiring extra work by faculty to achieve transfer outcome.
 - iii) Full time music faculty must teach six courses per semester to retain full time status.
 - iv) Courses formerly 3 units reduced to 1 unit without corresponding workload decrease,
 - v) Performance classes like ensembles consistently have 50+ students per course.
 - vi) Curriculum prevents change from "lab" to "lecture;" however labs require more contact hours than lectures.
- 5) Negotiations Discussion on Distribution of Total Compensation & member feedback.
 - a) EC discussed ideas and methods for surveying AFT members about upcoming distribution.
- 6) Initial Workload Draft Proposal for AFT EC and Member feedback.

- a) EC had in-depth discussion on how to survey members and content of survey and collaboration with Academic Senate on draft proposal for negotiations.
- 7) February and March 2019 EC Meeting Minutes.
 - a) Starting May 2019 AFT EC meetings will begin at 2:30. Moved and reflected in minutes.
